Privacy Statement

My Sister My Friend Breast Cancer Support uses its best efforts to respect the privacy of its online visitors. On our site, we do not collect personally identifiable information from individuals unless they provide it to us voluntarily and knowingly. This means we do not require you to register or provide information to us to view our site. My Sister My Friend Breast Cancer Support only gathers personally identifiable data, such as names, addresses, zip/postal codes, email addresses, etc., when voluntarily submitted by a visitor. For example, personally identifiable information may be collected to respond to a stated desire to volunteer or become a recipient. This information is used solely by My Sister My Friend Breast Cancer Support board members or other entities (staff members and volunteers) who are involved in the operation of this site for internal purposes. My Sister My Friend Breast Cancer Support lists are never sold to third parties. We will only share personally identifiable information with third parties when (i) the person submitting the information authorizes us to share it; (ii) sharing the information is a necessary operation of the site, or (iii) we are required to by law.

Is My Personal Information Secure?

Yes. The same high-grade encryption and HTTPS security protocols used for financial transactions on our site are used in collecting personal information.

We Care About Accuracy

In addition to maintaining privacy and security controls over information you share with us; My Sister My Friend Breast Cancer Support works to accurately process your information.

As necessary, changes are made to improve our systems. Independent external and internal audits are conducted to ensure the privacy, security, and appropriate processing of your information on our site.

How We Use "Cookies"
